PRESENTATION

Airport Industrial Park Properties Work Study Update. Brian Gouran presented the

to look at a long-term larger vision for the industrial area around the airport and a
discussion with the Commissioners before any RFPs and consultants are hired.

General consensus is that the work study is helpful for priorities, direction and understanding from the Commission.

ACTION ITEMS

 Motion to approve two new leases with Aircraft Hangars Northwest, LLC and authorize the Interim Executive Director to execute documents needed for the proposed development at Bellingham International Airport.

<u>Discussion:</u> Commissioners asked for clarification from Gary Kocher, Aircraft Hangars Northwest LLC on the use of the hangars.

Commissioner Bell called for a second public comment period. Commission heard from two individuals.

OTHER BUSINESS

- 1. Commissioner Shepard and Bell would like the ballot resolution for increasing the Commission size from 3 to 5 to be on the next agenda in July. Commissioner Briscoe does not believe it is necessary for the Commission size to increase.
- 2. Commissioner Briscoe requests that Warehouse 9 in Fairhaven be removed sooner than 2026 due to a possible loss of revenue if it is not removed.
- 3. Commissioner Bell commented on the extensive upcoming Executive Director recruitment that will be taking place and noting it will likely take 4-6 months including stakeholders and public input. Commissioners would like to be included prior to the contract agreement with a recruiter.
