| <b>Islander Parking Permit</b><br><br>San Juan Islands residents who show proof of residency. Allows essential needs to be met on the mainland (medical, grocery) | \$90.00 for 6 months; \$150 for 12 months. All fees based on calendar year. Non-refundable.  |
| <b>Non-Domicile Employee Parking Permit</b><br><br>For airline employees who do not work at BLI. Must provide proof of airline employment.                        | \$90.00 for 6 months; \$150 for 12 months. All fees based on calendar year. Non-refundable.  |
| <b>Lost/ Unreturned RFID Parking Pass Fine*</b>   | \$30.00 per RFID Parking Pass *Refunded if returned within 90 days*  |
| <b>Promotional Programs / Rate Adjustments</b>  | The Executive Director may respond to changing market conditions by offering discount coupons, parking promotional opportunities and parking rate adjustments.   |
| <b>Electric Vehicle Reserved Parking</b>  | Online service fee up to a maximum of \$12 per reservation (prepaid) + sales tax. In addition to the daily rate, plus a surcharge for premium parking is set by the Executive Director based on market conditions. |
| <b><u>License to Operate Fees</u></b>   |  |
| <b>Business License</b>   | \$125 annual fee   |
| <b>Courtesy Shuttle Operators</b>   | \$60/month   |
| <b>Taxi Cab Operators</b>   | \$30/month fee plus 3% on monthly sales over \$750   |
| <b>Infrequent Taxi/Limo/Shuttle Operator Use Fee</b>  | \$10/Trip maximum 4 trips per year   |
| <b>Limousine Operators</b>  | \$125/annual fee plus 3% on monthly sales over \$750   |
| <b>For Hire Shuttle/Bus Operators</b>   | \$35/month fee plus 3% on monthly sales over \$750   |
| <b>Offsite Airport Parking Lot Shuttle Operators</b>  | \$150/month fee  |
| <b>Transportation Network Company (TNC)</b>   | \$3.50 per trip for passenger drop off/ pick up  |
| <b>Ground Transportation Service Operator (GTSO) Requirements Fine</b>  | \$100 per violation  |

| <i>**First four hours free, more than four hours will be charged a minimum of one day**</i>  |   |
| <b>Single Engine</b>   | \$11.00/day *If not paid prior to departure, additional \$20 administration fee charged*  |
| <b>Twin Engine</b>   | \$22.00/day *If not paid prior to departure, additional \$20 administration fee charged*  |
| <b>Jets</b>  | \$44.00/day *If not paid prior to departure, additional \$20 administration fee charged*  |
| <b>Air Taxi</b>  | \$230 annual fee plus landing fees  |
| <b>Non flyable/Derelict Aircraft Fine</b>  | \$10.00/day for 60 days from date of notice until removed, w/ removal at owner's expense after 60 days  |

| <b>Commercial (SIDA)</b>   | \$60.00 per application + sales tax   |
| <b>Lost (individual) or unreturned (employer) Fine*</b>  | \$100.00 per card *Refunded if returned within 90 days  |
| <b>Reprint (damaged/faded/lost)</b>  | \$20.00 per card + sales tax  |
| <b>Renewal (within 30 days of expiration)</b>  | \$40.00 per SIDA application with fingerprinting services + sales tax<br>\$20.00 per non-SIDA application or SIDA application without fingerprinting services + sales tax |
| <b>Security/Safety Violation</b>   | \$50.00 2nd Violation<br>\$100.00 3rd Violation   |
| <b>Fingerprinting (no badge issued)</b>  | \$35.00 per occurrence + sales tax  |
