# **Economic Overview, Whatcom County**

Hart Hodges, Ph.D., Director of Western Washington University's Center for Economic and Business Research

Dr. Hodges provided insight into recent census data regarding household income and poverty, highlighted in the "Bellingham's median income dropped \$12K in 2023, poverty up 53%, new Census Bureau data says" article published in the Bellingham Herald on September 14, 2024.

Dr. Hodges cautioned against drawing conclusions from a single-year American Community Survey estimate, as they are less reliable due to small sample sizes. He highlighted that survey response rates dropped significantly post-COVID, especially among low-income households, which introduced sampling and weighting challenges.

Hodges explained that the reported rise in poverty reflects a return to pre-COVID trends following the expiration of pandemic-related stimulus measures. The apparent decline in household income may stem from statistical adjustments rather than actual economic changes. Hodges emphasized using multiple data sources to interpret trends and provided reassurance that the reported figures do not indicate significant structural shifts in the local economy.

### Joint List of Housing Policies - Climate Action & Business Commerce

Troy Muljat, Co-Chair of the Whatcom County Business and Commerce Housing Sub-Committee

Troy reviewed a joint draft housing policy document on behalf of WCBCC Housing Sub-Committee and the Climate Action Advisory Committee, reflecting mutual agreement on housing priorities between the two committees for recommendation to the Whatcom County Comprehensive Plan's Housing Chapter (2025).

The Housing sub-committee recommended approving the draft housing policy document as written and bringing it forth to the Climate Advisory Committee for final approval.

Ryan Allsop moved to approve, seconded by Paul Burrill for finalization as written. Motion passed.

### **Severe Weather Shelter Discussion**

Dan Dunne, Co-Chair of the Whatcom County Business and Commerce Housing Sub-Committee

Dan Dunne provided a review of the memorandum of recommendations derived from a sub-committee of the WCBCC Housing Advisory Committee tasked with providing recommendations to Whatcom County Council regarding the severe weather shelter. Members of the sub-committee included: Whatcom County Health Department, Lighthouse Mission, Lydia Place, DVSAS, Ferndale Community Services, Opportunity Council, City of Blaine, City of Bellingham, Lummi Nation, Northwest Youth Family Services, City of Bellingham Emergency Management, and community members impacted by homelessness.

The review of the memorandum was to solicit feedback specific to the winter shelter. Recommendations on general sheltering will be provided at some point in the next year.
